6. Industry shall comply with all the relevant acts/rules, directions, guidelines, notifications issued by MoEF/CPCB/MPPCB/Hon'ble Court from time to time as required and, if applicable.
7. Industry shall submit a fresh application for next renewal of consent u/s 21 of Water (Prevention & Control of Pollution) Act, 1981 180 days before the expiry of the date of this consent renewal letter.
The application shall be made in prescribed application form with consent renewal fee along with report of compliance of consent conditions mentioned in original consent letter and its subsequent consent renewal letter.
The consent renewal fee shall be payable as per latest gazette notification dated: 07/10/09 in accordance with gross block mentioned.
